



HealthSpring Medicare Advantage

Important Plan Changes — Effective May 1, 2026

Health Care Service Corporation (HCSC) has announced market changes affecting select HealthSpring Medicare Advantage plans. Beginning with applications signed on or after **May 1, 2026**, a number of plans will be designated as either **Non-commissionable** or **Suppressed**.

Non-commissionable Commissions will no longer be paid on these plans, and they will be removed from all broker enrollment platforms.

Suppressed These plans will be removed from all broker enrollment platforms.

Applications signed PRIOR to May 1, 2026 are not affected — agents will receive full commissions for those enrollments. Renewal commissions for existing members are also unaffected. These changes apply to the 2026 plan year and will be re-evaluated for 2027.
